

## 2016.11.17 修正生效條文

Please find below a short description of each modification.

1. The following rule changes have been confirmed and have already been implemented at the AIBA Youth World Championships St. Petersburg 2016:

- **Rule 3 & 4 of the Technical Rules: Scoring System & Decisions**

- In AOB competitions, all five (5) judges' scorecards counted to determine the winner of a bout.
- For each bout, the selection of Referee and Judges must be performed by an electronic draw by the Swiss Timing system.
- No scores between rounds will be released on television and internet, only at the end of each bout.

- **Rule 7.3.1 and 7.4.1 of the Technical Rules: Low Blow**

- Change in the wording of the Low-Blow rule to: referee "may" give a warning instead of "will".

- **Rule 13 of the AOB Competition Rules: Rules for International Technical Officials**

- Referee Evaluator and Judge Evaluator positions recognised as International Technical Official positions.
- Draw Commission is removed. Only the Commission Chairman remains as "Draw Commissioner" and he will be in charge to confirm the electronic draw done by Swiss Timing together with the Supervisor.

- **Rule 9 of the AOB Competition Rules: Field of Play**

- Judges on all four (4) sides of the ring.
- Size of the FOP reduced in order to bring the spectator closer to the action.

To allow all National Federations to apply to the new rule, related to the five (5) judges and the electronic draw, Swiss Timing will provide an update which will be available for download in January. Until then, this period will be considered as a transitional period where the usage of the old system will be tolerated at National level.

2. Besides the above confirmed and implemented rules, the following rules' changes have been confirmed and are already in force:

- **Rule 2.2.2 of the Technical Rules: Eligibility on Sport related issues**

- The restriction on professional boxers to compete at National or International level is lifted and they become eligible to compete in AIBA events, as long as they comply with the requirements set out by their respective National Federation.
- The restriction on others combat sports athletes has softened, especially with the cancellation of the waiting period.

- **Competition Calendar**

- A new competition calendar has also been approved by the AIBA Executive Committee, with the aim to deliver a clear vision to the National Federations for

the next Olympic Cycle and ensure alignment between National, Confederations and AIBA tournaments. The main rationale of this change is to align Men's and Women's Competition on the same year and replicate this approach with the Elite Events then use all Continental Championships as Qualifying events for all AIBA World Championships. We are also considering allowing Mixed Gender Events at Continental level after review and approval by AIBA and the adequate Commissions.

- This change will bring to the boxing family several advantages:
  - All major international events are spread across the year without any overlap.
  - Increased value for the Continental Championships.
  - Reduction of costs for National Federations.
  - Additional possibilities for boxers to enter AOB & WSB events.
  - Possibility for AIBA ITOs to work across a period of 12 months.
  - Improved media exposure for AIBA Events.
  
- 3. To conclude, the already confirmed following rule changes will be applied after January 1<sup>st</sup> 2017:
  - **Rule 1.1 of the Technical Rules: Age Classification**
    - Rule 1.1.4 regarding age classification is maintained
    - Rule 1.1.6.3 is removed
    - For Youth Category, the 17-18 years old range will be maintained with the year of birth as reference.
    - Below the Youth Category, the Junior and the Schoolboys have a two-year span and Confederations and National Federations may organise events for these categories.
  
  - **Rule 11 of the Technical Rules:**
    - 3 Judges for APB and WSB events
  
  - **Rule 4 of the Technical Rules: Decisions**
    - Revert to using RSC in place of TKO in competitions
    - TKO replaced by Abandon when a Coach decides to stop the bout
    - Revert to using RSC-Injury in place of TKO Injury in competitions.

## 2016.12.19 修正生效條文

### **Compliance to the Rules (Technical)**

National Federations, for domestic competitions, may alter the AIBA Technical Rules to reflect National laws or conditions, as long as, the alteration does not diminish the rules, especially regarding Medical and Safety requirements.

#### **Rule 8 of the Technical Rules: Caution, warning, disqualification**

- If a Boxer receives head butting or illegal blows which do not cause an injury or a cut, the Referee will give a Warning to the offending Boxer, deducting one (1) point per Judge or may disqualify the offending Boxer if actions deemed sufficiently serious to warrant a disqualification
  - If a Boxer receives head butting or illegal blows which cause an injury or a cut the Referee must disqualify the offending boxer.
- *The Rule is strengthened*

#### **Rule 12 of the Technical Rules: AIBA R&J Management**

- AIBA is responsible for the certification of all Star Level R&J.
- *Reference to National level deleted*

#### **Rule 3 of the Technical Rules: Scoring System**

- For APB and WSB bouts, three (3) Judges will be used for each bout and will be allocated a position around the ring through a manual draw performed by the supervisor.

#### **Rule 5 of the Technical Rules: Protest**

- AOB - If the Supervisor believes that the decision of the referee has been taken in contravention of these Technical Rules and /or of the AOB Competition Rules, the Supervisor must fill in the Bout Review Request Form (as per appendix D) and call for a meeting with the Deputy Supervisors and the RJ Evaluators. The Supervisor must, through the Bout Review Request Form, inform both concerned Team Delegations immediately of the decision.
- *The Rule is simplified*

### **Compliance to the Rules (AOB)**

National Federations, for domestic competitions, may alter the AOB Competition Rules to reflect National laws or conditions, as long as, the alteration does not diminish the rules, especially regarding Medical and Safety requirements.

#### **Rule 15 of the AOB Competition Rules: AIBA Cutman**

- When appointed to competitions without Headguards, the AIBA Cutman controls the handwraps, prepared by the Coaches and intervenes only if necessary. He oversees the work of the Team's cutmen at the corner and provides advice to the Seconds if necessary. The AIBA Cutman also conducts Handwrap Workshops, Seminar or Courses for Coaches.

- When appointed to competitions with Headguards, the AIBA Cutman conducts Handwraps Workshops, Seminars or Courses for Coaches.
- *The role of the AIBA Cutman evolves, as the team's cutman is now empowered to treat his own boxer during the breaks.*

### **Rule 5.8 of the AOB Competition Rules: Bout Schedule**

- At the request of the Host Broadcaster, and in agreement with the Supervisor, the bout schedule of a given day can be amended, so that boxers from a same nationality box consecutively within the same session, even if they were originally planned in two different sessions. This arrangement is possible as long as the two following conditions are met:
  - The new bout schedule is communicated to the teams one day before the scheduled bout.
  - If one bout is moved from a session to another session, the bout of the next direct opponent shall be moved as well.
- *This change aims to better market our sport.*

### **Rule 6 of the AOB Competition Rules: Duration and Number of Rounds**

- In all AOB Elite Men and Women and Youth Boys and Girls Competitions, the Bouts must consist of three (3) rounds of three (3) minutes each.

### **Rule 9.3 of the AOB Competition Rules: ITO positions in and around the FOP**

- The R&J Coordinator(s) chair(s) must be placed in the same area as the stand-by RJ chairs.
- The R&J Evaluators table must be placed immediately behind the advertising banners on the same side as the Supervisor's table and the Draw Commissioner's table, as mentioned in the FOP layout set up in article 9.1 and 9.2.

### **Appendix A of the AOB Competition Rules: Competition Guidelines**

- AOB 3 - Star Competitions - AIBA International Tournaments - World Championships System
  - From 2017 and onwards, the Elite Men World Championships will be held only with Boxers who qualified through all Continental Championships.
  - From 2019 and onwards, the Elite Women World Championships will be held only with Boxers who qualified through all Continental Championships.
  - From 2018 and onwards, the Youth World Championships, Boys and Girls, will be held only with boxers who qualified through all Continental Championships.
- AOB 2-Star Competitions – AIBA Confederation Competitions
  - Continental Confederation Qualification Championships for Women, and Men
  - Oceanian Confederation Championships.

### **Rule 21 of the AOB Competitions Rules: Hairnet Rule**

For all boxers not wearing Headguards with hair below the neckline, a hair net or any other item must be worn to control the hair. The Seconds have to ensure that the hair is secured appropriately.
