Dear Presidents and Secretary Generals,

This letter is to inform you of the upcoming AIBA 2-Star R&J course that will take place during the Monkstown Box Cup 2018 hosted in Monkstown, Ireland.

This is an extraordinary opportunity for National Federations from AFBC, ASBC, EUBC and OCBC to enrol their best eligible R&Js. The main objective here is to help develop R&Js and increase the pool of elite officials around the world.

Please review the following information below which details the logistics and eligibility for the course.

### **Invitation to AIBA 2-Star R&J Certification Course**

#### **1. Course Description:**

The course consists of 3 parts; theoretical, practical and written examination. The theoretical part will take place before the start of the Monkstown Box Cup, while the practical portion of the course will take place during the Tournament. Therefore, each applicant selected for the course will automatically be appointed to work as a Referee and Judge during this event.

#### **2. Location and Dates:**

Monkstown, Ireland

- Arrival date: June 26, 2018
- Course dates: June 27-July 1, 2018
- Departure date: July 2, 2018

#### **3. Eligible Applicants:**

- Current Certified and active 1-Star R&Js for at least 12 months or
- Current Certified 2-Star R&Js not active in AIBA events and/or last certified in 2012 or later

**Note:** R&Js already certified as 2-Star R&Js and currently active are not required to attend this course. The AIBA R&J Commission will review all applications and make a selection shortly after the course application deadline. AIBA will immediately confirm the acceptance of the R&Js that can attend the course.

#### 4. Financial Terms and Conditions:

The applicants or their respective National Federation must cover the following expenses:

- Flights
- Visa
- Accommodations (cost covers room and 3 meals a day)
  - Triple Room - 85 EUR
  - Double Room – 100 EUR
  - Single Room – 160 EUR
- Course Fee:
  - \$200 USD

*\*We would like to inform you that all the selected participants will be obliged to pay the course fee regardless if they attend the course or not.*

#### 5. Application Process:


- All National Federations must enrol their applicants by using the AIBA database. Please follow the attached module to apply for the course.

- When registering participants please select the room preference (Single or Double) and indicate if a visa is required (Yes/No)

- The deadline is **May 18, 2018** for all applications.
